THIS CAUSE is before the State of Florida, Agency for Health Care Administration ("the Agency") concerning the preliminary approval of Certificate of Need ("CON") 10302 filed by VITAS Healthcare Corporation of Florida ("VITAS") to establish a new hospice program, with respect to the fixed need pool for Sub-District 6-A.

The Agency comparatively reviewed CON applications for other beds and 1. programs batching cycle with an application due date of February 20, 2015 for Sub-District 6-A. For the case at hand, the reviews included in relevant part:
