THIS CAUSE is before me for entry of a final order concerning Petitioner's application for renewal of its child care facility license. The Recommended Order concluded that Petitioner's owner physically injured a child entrusted to his care. The AJ also concluded that Petitioner had a multi-year history of violating the licensing requirements of section 402.305, Florida Statutes, and Florida Administrative Code Rules 65C-22.002, 65C-22.003, 65C-22.004, 65C-22.005, and 65C-22.006. The ALJ recommended that the Department deny Petitioner's application for renewal of its child care facility license. Neither party filed exceptions to the Recommended Order.

Accordingly, the Recommended Order is approved and adopted and Petitioner's application for renewal of its child care facility license is **DENIED**.
