# FINAL ORDER

THIS CAUSE is before the State of Florida, Agency for Health Care Administration ("the Agency") concerning the denial of Certificate of Need ("CON") 10348 filed by North Brevard County Hospital District d/b/a Parrish Medical Center ("Parrish") to establish a new 16-bed comprehensive medical rehabilitation ("CMR") unit in Brevard County, Service District 7, and the denial of CON 10349 filed by Osceola Regional Hospital, Inc., d/b/a Osceola Regional Medical Center ("Osceola") to add 28 CMR beds to its hospital, located in Osceola County, District 7.

- 1. On June 8, 2015, the Agency published notice in the Florida Administrative Register of its denials of CON Application No. 10348 and CON Application No. 10349.
- 2. On June 22, 2015, Parrish filed a Petition for Formal Administrative Hearing to contest the denial of its Application for CON No. 10348 to establish a CMR unit at its existing

hospital in Osceola County, AHCA District 7. The Agency AHCA referred the Petition to the Division of Administrative Hearings ("DOAH").

3. On June 23, 2015, Osceola filed a petition for a Formal Administrative Hearing to contest the denial of its CON Application No. 10349 to add 28 CMR beds to its hospital, located in Osceola County, District 7, and contest the denial CON Application number 10348 filed by Parrish to add 16 CMR beds to its hospital located in Osceola County, District 7. The Agency referred this Petition to DOAH.

4. On July 8, 2015, HealthSouth of Sea Pines Limited Partnership d/b/a HealthSouth Sea Pines Rehabilitation Hospital ("HealthSouth") filed a Petition to Intervene in support of the Agency's preliminary denial of Parrish's CON application 10348.

- 5. The DOAH thereafter issued an Order of Consolidation for the two cases.
- 6. On December 3, 2015, Parrish filed a Notice of Voluntary Dismissal.
- 7. On December 8, 2015, the DOAH entered an Order Severing and Closing the File on Case No. 15-3830CON.
- 8. Case No. 15-3831CON concerning CON Application No. 10349 remains pending with the DOAH.

## It is therefore **ORDERED**:

1. The denial of CON Application 10348 filed by North Brevard County Hospital District d/b/a Parrish Medical Center is UPHELD.
