SUPPLEMENTAL FINAL ORDER ON REMAND

On remand from the Florida Supreme Court, the First District Court of Appeal issued the following opinion:

The Florida Supreme Court has directed us to remand this case to the administrative law judge with direction "to reduce AHCA's lien amount in this case to \$13,881.79." *Giraldo v. AHCA*, 248 So. 3d 53, 56 (Fla. 2018). We hereby do so.

Giraldo v. Ag. for Health Care Admin., Case No. 1D16-392 (slip op., Oct. 18, 2018). That opinion became final and the court's mandate directed to the undersigned was issued November 8, 2018.

No further proceedings are necessary or appropriate to carry out the direction.

Accordingly, as directed, it is found and concluded that the Agency for Health Care Administration's lien in this case shall be reduced to \$13,881.79.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is ORDERED that the Agency for Health Care Administration's lien in this case is reduced to \$13,881.79.

NOTICE OF RIGHT TO JUDICIAL REVIEW

A party who is adversely affected by this Final Order is entitled to judicial review pursuant to section 120.68, Florida Statutes. Review proceedings are governed by the Florida Rules of Appellate Procedure. Such proceedings are commenced by filing the original notice of administrative appeal with the agency clerk of the Division of Administrative Hearings within 30 days of rendition of the order to be reviewed, and a copy of the notice, accompanied by any filing fees prescribed by law, with the clerk of the District Court of Appeal in the appellate district where the agency maintains its headquarters or where a party resides or as otherwise provided by law.
