FINAL ORDER

THIS CAUSE came before me for final action on Amengual Electric, Inc.'s ("Employer") request for administrative review ("petition") challenging a Stop-Work Order and Order of Penalty Assessment and an Amended Order of Penalty Assessment.

FINDINGS OF FACT

1. On June 11, 2015, the Department of Financial Services, Division of Workers' Compensation ("Department") served Employer a Stop-Work Order and Order of Penalty Assessment.
2. On August 27, 2015, the Department served Employer an Amended Order of Penalty Assessment. The amended order assessed a total penalty of \$126,758.32.
3. On September 18, 2015, the Department received Employer's petition.
4. On February 29, 2016, Employer withdrew the petition.
5. On March 9, 2016, the Department served Employer the 2nd Amended Order of Penalty Assessment. The 2nd amended order assessed a total penalty of \$4,845.58. Employer did not file a petition or otherwise contest the 2nd amended order.
6. The factual allegations contained in the Stop-Work Order and Order of Penalty Assessment and the 2nd Amended Order of Penalty Assessment are hereby adopted as the Department's findings of fact in this case.

CONCLUSIONS OF LAW

7. Based upon the findings of fact adopted herein, the Department concludes Employer violated the specific statutes and rules as alleged in the Stop-Work Order and Order of Penalty Assessment and the 2nd Amended Order of Penalty Assessment.

Accordingly:

a. Employer shall immediately execute a payment agreement or pay the penalty of \$4,845.58 in full to the Department for deposit into the Workers' Compensation Administration Trust Fund;

b. Employer shall immediately cease all business operations in the state of Florida until such time as the Department issues an order releasing the Stop-Work Order and 2nd Amended Order of Penalty Assessment. The Department shall not issue an order releasing the Stop-Work Order and 2nd Amended Order of Penalty Assessment until Employer has come into compliance with the coverage requirements of chapter 440, Florida Statutes, and has paid the total penalty of \$4,845.58 to the Department.
