FINAL ORDER

This consolidated proceeding was initiated by Petitioner, Outfront Media, LLC, (Outfront) filing Petitions for Formal Proceedings in response to Notices of Unauthorized Removal, Cutting or Trimming of Vegetation (Notices) issued by the Respondent, Department Of Transportation (Department). Before hearing, the parties entered into a Stipulation of Settlement resolving all issues in these matters.

FINDINGS OF FACT

- 1. Outfront owns several permitted outdoor advertising signs in Monroe County, Florida. Between July 29, 2015 and September 10, 2015, the Department notified Outfront that vegetation had been removed, cut, or trimmed along Department right of way in front of Outfront's permitted signs, without vegetation management permits in violation of Department rules.
- 2. On August 26, 2016, Outfront filed six timely requests for an administrative hearing with the Department. On October 5, 2015, Outfront filed an additional request for an administrative hearing after receiving a reissued notice of violation.

- The matters were referred to the Division of Administrative Hearings on October 6,
 and consolidated by Order of October 14, 2015.
- 4. Prior to hearing, the Department and Outfront entered into the attached Stipulation of Settlement resolving the matters. On January 29, 2016, the Division of Administrative Hearings relinquished jurisdiction to the Department.

CONCLUSIONS OF LAW

- A. The Department has jurisdiction over the subject matter of and the parties to this proceeding pursuant to Chapters 120 and 479, Florida Statutes, and Rule Chapter 14-10, Florida Administrative Code.
- B. The Stipulation of Settlement resolves the violations that were the subject of the Petitions for Formal Proceedings.

ORDER

Based on the above Findings of Fact and Conclusions of Law, it is

ORDERED that the attached Stipulation of Settlement is approved. It is further

ORDERED that the request for an administrative hearing filed by Outfront Media, LLC, is **DISMISSED.**
