FINAL ORDER

On September 30, 2015, the Department of Transportation ("Department") issued a Notice of Intent to Permit the City of Tampa to open a new public highway-rail grade crossing at the corner of Tyson Avenue and Bridge Street in Hillsborough County, Florida, over a rail spur owned and operated by CSX Transportation, Inc. ("CSX"). CSX filed a Petition for Formal Administrative Hearing and the matter was referred to the Division of Administrative Hearings. New Port Tampa Bay CCD Holdings, LLC and New Port Tampa Bay CDD subsequently intervened in the case. Pursuant to notice, a hearing was conducted before the assigned Administrative Law Judge (ALJ), Linzie F. Bogan, on February 23 and 24, 2016. The ALJ entered a Recommended Order on April 22, 2016, recommending the Department enter a final order approving the new opening.

A copy of the Recommended Order is attached. No exceptions were filed.

STATEMENT OF THE ISSUE

As stated in the Recommended Order, the issue presented was whether the opening of a public highway-rail grade crossing at the proposed intersection of Tyson Avenue and Bridge Street in Hillsborough County, Florida, meets the criteria set forth in Florida Administrative Code Rule 14-57.012(2)(a)(1-3).

FINDING OF FACT

The Findings of Fact in paragraphs 1 through 20 of the Recommended Order are supported by competent, substantial evidence and are adopted and incorporated as if fully set forth herein.

CONCLUSIONS OF LAW

The Conclusions of Law in paragraphs 21 through 31 of the Recommended Order are fully supported in law, and are adopted and incorporated as if fully set forth herein.

<u>ORDER</u>

Based on the foregoing Findings of Fact and Conclusions of Law, the Department approves the opening of a public highway-rail grade crossing at the intersection of Tyson Avenue and Bridge Street in Hillsborough County, Florida in accordance with the September 30, 2015 Notice of Intent.
