#### FINAL ORDER

THIS CAUSE, came before The School Board of Palm Beach County, Florida (hereinafter referred to as "SCHOOL BOARD") pursuant to §120.569 and §120.57, Fla. Stat., after an administrative hearing was conducted before the Honorable June C. McKinney on October 14, 2016. The Recommended Order was entered by the Honorable June C. McKinney on January 4, 2017, recommending that a final order be entered by the Palm Beach County School Board upholding Respondent's suspension without pay and termination for just cause.

#### IT IS ORDERED AND ADJUDGED as follows:

- 1. That the Board has jurisdiction of this matter pursuant to §120.57, Fla. Stat.
- 2. That the Board hereby accepts and approves the findings, conclusion and recommendations of the Recommended Order dated January 4, 2017, a copy of which is attached hereto and incorporated herein by reference in its entirety.
  - 3. Based upon the recommended order, it is further ordered as follows:
- a) The charges of violations of policies 0.01(2)6, 3.02(4)(a), (d), (e), and (g); 5(a), (a)(iii), (a)(v), and (a)(viii); 1.013(4); and rule 6A-10.081(3) (e) and (h) shall be dismissed;
- b) The charges of violations of rules 6A-10.080(2) and (3), 6A-5.056(2), 6A-10.081(3)(a), policies 0.01(2)3., 1.013(1), 3.02(4)(b), and 3.02(5)(a)(vii) are as charged;
- c) The Respondent's suspension shall be upheld without pay and he shall be terminated for just cause.
- 4. That this Final Order shall take effect upon being filed with the Clerk of the School Board.
