AMENDED FINAL ORDER

THIS MATTER is before the Department of Health ("Department") upon execution of a settlement agreement between Loop's Nursery and Greenhouses, Inc. ("Loop's") and the Department.

BACKGROUND

On December 14, 2015, Loop's filed a Petition for Formal Administrative Proceeding challenging the Department's denial of its application to become a low-THC cannabis dispensing organization in the Northeast region. An administrative hearing was held and on January 5, 2017, the Department issued a Final Order denying Loop's petition.

Loop's filed an appeal of the Final Order in the First District Court of Appeals, Case No. 1D17-0237.

On July 31, 2017, Loop's and the Department entered into a settlement agreement, attached as Exhibit A, approving Loop's for licensure as a medical marijuana treatment center in accordance with section 381.986(8)(a)2.a., Florida Statutes (2017).

The settlement agreement resolves all controversies between the parties in this matter.

<u>ORDER</u>

Based on the foregoing, the Order section of the Final Order rendered on January

5, 2017, is amended to state the following:

The settlement agreement, attached as Exhibit A is approved, adopted and

incorporated by reference in this Final Order.

Loop's is approved to be licensed as a medical marijuana treatment center in accordance with section 381.986(8)(a)2.a., Florida Statutes (2017).
