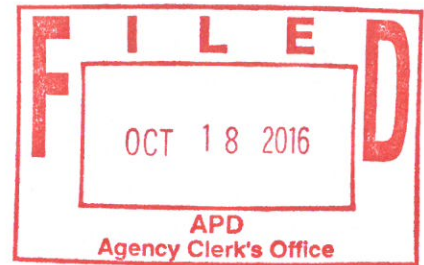

FINAL ORDER

On December 4, 2015, the Agency for Persons with Disabilities issued an Administrative Complaint against Respondent, New Life Charities, Incorporated, Owner and Operator, Janae House Group alleging multiple violations of Florida Rules and Statutes. The Agency was seeking to revoke the Respondent's group home license number 13002298A.

Following an administrative hearing at the Division of Administrative Hearings on March 24th, 2016, the Administrative Law Judge issued a Recommended Order, incorporated herein, concluding that Respondent violated the group home licensing standards, and directing the Agency for Persons with Disabilities to enter a final order revoking Respondent's group home license. Neither party filed exceptions to the Recommended Order. The Recommended Order is approved and adopted.

Accordingly, upon review of the complete record in this case, including the recommended order, submissions and arguments of the parties, and being otherwise fully advised in the premises, Respondent's group home license is hereby REVOKED.

NOTICE OF RIGHT TO APPEAL

A party who is adversely affected by this final order is entitled to judicial review. To initiate judicial review, the party seeking it must file one copy of a "Notice of Appeal" with the Agency Clerk. The party seeking judicial review must also file another copy of the "Notice of Appeal," accompanied by the filing fee required by law, with the First District Court of Appeal in Tallahassee, Florida, or with the District Court of Appeal in the district where the party resides. The Notices must be filed within thirty (30) days of the rendition of this final order.¹

¹ The date of the "rendition" of this Final Order is the date that is stamped on its first page. The Notices of Appeal must be received on or before the thirtieth day after that date.


