
FINAL ORDER

Having reviewed the Notice of Intent to Deny, and all other matters of record, the Agency for Health Care Administration finds and concludes as follows:

1. The Agency issued the above-named Petitioner the attached Amended Notice of Intent to Deny Renewal Application for a Standard Assisted Living License. (Ex. 1). The parties have since entered into the attached Settlement Agreement, which is adopted and incorporated by reference into this Final Order. (Ex. 2)

2. The Agency has since processed the CHOW application received by the Agency and issued a provisional license to the CHOW applicant. To the extent necessary, the Agency may process the Licensee's renewal application and issue a renewal license for the period from the expiration of the former licensee's license and the beginning of the CHOW applicant's provisional license.



NOTICE OF RIGHT TO JUDICIAL REVIEW

A party who is adversely affected by this Final Order is entitled to judicial review, which shall be instituted by filing one copy of a notice of appeal with the Agency Clerk of AHCA, and a second copy, along with filing fee as prescribed by law, with the District Court of Appeal in the appellate district where the Agency maintains its headquarters or where a party resides. Review of proceedings shall be conducted in accordance with the Florida appellate rules. The Notice of Appeal must be filed within 30 days of rendition of the order to be reviewed.
