
**FINAL ORDER**

ORDER CLOSING FILE AND RELINQUISHING JURISDICTION

On February 26, 2016, Respondent filed a "Motion to Dismiss; Incorporated Points and Authorities; and Declaration in Support Thereof" ("the Motion to Dismiss"). When Petitioner failed to file a response within the time period set forth in Rule 28-106.204(1) of the Florida Administrative Code, the undersigned issued an Order on March 7, 2016, requiring Petitioner to file a Response to the Motion to Dismiss by March 17, 2016. In addition, the aforementioned Order specified that "[f]ailure to comply with this Order may result in the undersigned closing the case file and relinquishing jurisdiction to the Department of Highway Safety and Motor Vehicles."

As of noon on March 21, 2016, Petitioner had yet to file a response to the Motion to Dismiss. Accordingly, it is

1. The final hearing scheduled for April 27 through April 29, 2016, is canceled.
2. The file of the Division of Administrative Hearings is closed. Jurisdiction is relinquished to the Department of Highway Safety and Motor Vehicles.
