FINAL ORDER

THIS CAUSE came for consideration and final agency action on the Recommended Order issued on July 7, 2016.

After review of the complete record and being otherwise fully apprised in all material premises, the administrative law judge's findings of fact, conclusions of law, and recommendation are adopted in full.

IT IS THEREFORE ORDERED that:

- (a) The untimely request for hearing is DISMISSED, with prejudice.
- (b) A \$58,944.86 penalty is imposed against Pioneer Construction, LLC, for its failure to secure workers' compensation coverage as provided in the Amended Order of Penalty Assessment.

(c) Pioneer Construction, LLC, must remit payment of the penalty to the Department, or execute a payment agreement with the Department to pay the penalty by installments.

NOTICE OF RIGHT TO APPEAL

A party adversely affected by this final order may seek judicial review as provided in section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d), and must be filed (i.e., received by the Agency Clerk) within thirty days of rendition of this final order.
