FINAL ORDER


THIS CAUSE came for consideration and final agency action on the Recommended Order issued on April 5, 2017.

This proceeding arose out of the Department's May 25, 2016, letter accepting the Florida Self-Insurers Guarantee Association's (FSIGA) recommendation that Payroll Management, Inc. (petitioner), increase its qualifying security deposit with FSIGA from \$5,144,108 to \$7,434,705. By letter dated June 1, 2017, the Department rescinded the May 25, 2016 letter, and rendered this proceeding moot. The Department's June 1, 2017, letter also increased petitioner's qualifying security deposit from \$5,144,108 to \$6,775,263, and provided petitioner with a clear point of entry into the administrative process to challenge that action, should petitioner choose to.

Accordingly, this administrative proceeding is DISMISSED as moot, and the Department's file in this matter is CLOSED.

NOTICE OF RIGHT TO APPEAL

A party adversely affected by this final order may seek judicial review as provided in section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d), and must be filed (i.e., received by the Agency Clerk) within thirty days of rendition of this final order.

Filing with the Department's Agency Clerk may be accomplished via U.S. Mail, express overnight delivery, hand delivery, facsimile transmission, or electronic mail.
