FINAL ORDER


THIS CAUSE is before me for entry of a final order concerning the Department's Administrative Complaint proposing to impose an administrative penalty of \$2,000 and revoke Respondent's child care facility license. The Recommended Order concluded that the Department had proven by clear and convincing evidence that Respondent had committed four Class I violations and multiple Class II and Class III violations and recommended that the Department revoke Respondent's license. The Recommended Order did not address the proposed administrative penalty, noting that the Department's Proposed Recommended Order did not mention the proposed penalty. Neither party filed exceptions to the Recommended Order.

Accordingly, the Recommended Order is approved and adopted and Respondent's child care facility license is hereby **REVOKED**.

NOTICE OF RIGHT TO APPEAL


