**AMENDED FINAL ORDER**

This matter came before the Department of Highway Safety and Motor Vehicles (Department) for entry of a Final Order upon submission of three Orders Closing Files by Mary Li Creasy, an Administrative Law Judge of the Division of Administrative Hearings, copies of which are attached and incorporated by reference in this order. The Department hereby amends its Final Order, No. HSMV-17-380-FOF-MS, filed on July 31, 2017, in this matter and finds and orders as follows:

1. Petitioners Pompano Automotive Associates, LLC d/b/a Joey Accardi Chrysler Dodge Jeep Ram; Schumacher Automotive Delray, LLC d/b/a Schumacher Chrysler Dodge Jeep Ram of Delray; and Yardley Car Company, LLC, timely filed petitions or complaints protesting the proposed establishment of Arrigo Margate, LLC d/b/a Arrigo Dodge Chrysler Jeep Ram Margate. The cases were consolidated at the Division of Administrative Hearings.

2. Petitioners subsequently dismissed their petitions and Administrative Law Judge Mary Li Creasy entered the attached Orders Closing Files.

Accordingly, it is,

**ORDERED and ADJUDGED** that Respondent, Arrigo Margate, LLC d/b/a Arrigo Dodge Chrysler Jeep Ram Margate be granted a license as a franchise dealership for Chrysler, Dodge, Jeep and Ram motor vehicles at 2250 North State Road 7, Margate (Broward County), Florida 33063-5716, upon compliance with all applicable requirements of section 320.27, Florida Statutes, and all applicable Department rules.
