FINAL ORDER

THIS CAUSE came for consideration and final agency action on the Recommended Order. After reviewing the record, including admitted exhibits, considering applicable law, and otherwise being fully apprised in all material premises, the Recommended Order is hereby adopted.

Accordingly, a \$13,687.24 penalty is imposed against Cobalt Shore Investments, LLC, for its failure to secure workers' compensation coverage as provided in the 3rd Amended Order of Penalty Assessment. Respondent must pay the penalty in full within thirty days (less any payments made to date) or execute a payment agreement with the Department to pay the penalty by installments.

NOTICE OF RIGHT TO APPEAL

A party adversely affected by this final order may seek judicial review as provided in section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d), and must be filed (i.e., received by the Agency Clerk) within thirty days of rendition of this final order.
