FINAL ORDER

THIS CAUSE is before the State of Florida, Agency for Health Care Administration (the "Agency") concerning the preliminary approval of Certificate of Need ("CON") Application 10450 filed by Adventist Health System/Sunbelt, Inc. d/b/a Florida Hospital ("Florida Hospital") to establish a new general acute care hospital campus of 100 beds and CON Application 10454 filed by Orlando Health Central, Inc. ("Orlando Health") to establish a new Class I general hospital

with 103 acute care beds in Orange County, Subdistrict 7-2.¹ Being fully advised in the premises, the Agency finds as follows:

1. Florida Hospital filed a petition for hearing supporting the Agency's preliminary approval of its CON application and challenging CON Application 10454 filed by the co-batched applicant, Orlando Health. (DOAH 17-1188CON)

2. Orlando Health filed an amended petition for hearing challenging the Agency's preliminary approval of Florida Hospital's CON Application 10450. (DOAH 17-0651CON)

3. The petitions for hearing were referred to the Division of Administrative Hearings, where they were consolidated for hearing.

4. On September 26, 2018, Florida Hospital filed a Notice of Voluntary Dismissal of its petition for hearing.

5. On September 26, 2018, Orlando Health filed a Notice of Voluntary Dismissal of its petition for hearing.

6. The Administrative Law Judge entered orders closing the cases and relinquishing jurisdiction to the Agency allowing the entry of final orders.


It is therefore **ORDERED:**

1. The Agency's preliminary approval of CON Application 10450 filed by Florida Hospital is UPHELD.

2. The Agency's preliminary approval of CON Application 10454 filed by Orlando Health is UPHELD.

¹ There was a total of four petitions for hearing for these co-batched applications. On August 8, 2017, the Agency issued an Amended Final Order issuing CON 10451 to Central Florida Health Services, LLC. On February 23, 2018, the Agency issued a Final Order dismissing the petition for hearing filed by Central Florida Health Services, LLC, which challenged the approval of CON Application 10450 filed by Florida Hospital.
