NOTICE OF DISMISSAL

Pursuant to the authority vested in me by the Florida Commission on Human Relations, I hereby issue the following notice dismissing the above-referenced complaint.

The Commission issued its Determination: No Jurisdiction on November 18, 2016. The Complainant filed a Petition for Relief with the Commission on Human Relations on January 30, 2017. Following proceedings before the Division of Administrative Hearings, the Division of Administrative Hearings issued a Recommended Order of Dismissal on March 22, 2017.
