Before a date was set for the formal hearing, the parties filed a Joint Motion to Relinquish Jurisdiction to Agency on April 6, 2017, seeking an opportunity for the parties to engage in settlement negotiations.

On April 7, 2017, the Honorable J. Lawrence Johnston, Administrative Law Judge of the Division of Administrative Hearings, issued an Order Closing Files and Relinquishing Jurisdiction. At the request of the parties, since that date, the cases have remained in abeyance before the Department while the parties have engaged in settlement negotiations.

On August 27, 2021, Petitioners filed their Notice of Voluntary Dismissal with Prejudice, which is attached and incorporated by reference, dismissing both protests. Petitioners' protests having been withdrawn, and upon review of the record in the above-styled causes and being fully advised in the premises, it is **ORDERED** that the petitions are **DISMISSED**. Accordingly, the cases are **CLOSED**.
