FINAL ORDER

THIS CAUSE concerns a Formal Written Protest that the petitioner Ernst & Young LLP (“Petitioner”) filed on March 10, 2017, protesting the terms, conditions, and specifications of Addendum 3 to AHCA ITN 001-16/17. On March 27, 2017, the Petitioner’s Formal Written Protest was referred to the Division of Administrative Hearings (“DOAH”) and assigned case number 17-1903BID. On April 5, 2017, the Petitioner filed a Notice of Voluntary Dismissal of its protest. On April 6, 2017, the Administrative Law Judge (“ALJ”) entered an order closing DOAH’s file.

REVIEW OF PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA APPELLATE RULES. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF THE RENDITION OF THE ORDER TO BE REVIEWED.
