THIS CAUSE came before the State of Florida, Agency for Health Care Administration ("the Agency") concerning the denial of Certificate of Need ("CON") Application No. 10470 filed by Comprehensive Home Health Care, Inc. d/b/a OpusCare of South Florida ("OpusCare") to establish new freestanding inpatient hospice facility consisting of 13 beds.

- The Agency Notice denying OpusCare's CON Application was published on 1. February 20, 2016 in the Florida Administrative Register.
- On March 6, 2017, OpusCare filed a Petition for Formal Administrative 2. Proceeding contesting the Agency's denial of its CON application. The cause was referred to the Division of Administrative Hearings.
- The parties have since entered into a Settlement Agreement (Exhibit 1) approving 3. CON Application No. 10470. (Ex. 1)

It is therefore **ORDERED**:

The Agency shall issue CON No. 10470 to OpusCare pursuant to the terms of the parties' settlement agreement.
