THIS CAUSE is before me for entry of a final order concerning the Department's Administrative Complaint signed April 28, 2017, imposing an administrative fine of \$50 for a second Class II violation of rule 65C-22.006(4)(e)1. and 4., relating to employee files for Armentha Edwards and Tamarra Morse. The Recommended Order, dated March 24, 2018 (although the Order was dated March 24, 2018, it was emailed to parties on April 24, 2018), concluded that the Department met its burden of proving the second Class II violation in reference to Armentha Edwards but not Tamarra Morse, and imposition of a fine as outlined in the Administrative Complaint. Neither party filed exceptions to the Recommended Order.

Accordingly, the Recommended Order is approved and adopted and the Administrative Complaint dated February 22, 2017 is **UPHELD** except for the allegation in reference to Tamarra Morse.
