#### FINAL ORDER

THIS CAUSE is before me for entry of a final order concerning the Department's Amended Administrative Complaint dated January 5, 2018, issuing a Notice of Intent to Revoke Child Care Facility Probationary License and a Notice of Intent to Deny Child Care Facility Licensure. The Recommended Order, dated March 20, 2018, concluded that the Responded did not commit the three Class II violations as alleged, instead finding that Respondent committed one Technical Support Violation. The Order recommends the Respondent not be found to have violated its probationary license and further recommends the Department not deny the renewal license. Neither party filed exceptions.
