FINAL ORDER

The Department of Business and Professional Regulation (“Department”), hereby enters this Final Order for the above styled matter.

1. On April 25, 2017, the Department issued an Administrative Complaint, a copy of which is attached as Exhibit “A”.
2. On November 22, 2017, a hearing in this case was held before the Honorable June C. McKinney, Administrative Law Judge, Division of Administrative Hearings.
3. On January 19, 2018, Administrative Law Judge June C. McKinney issued a Recommended Order, a copy of which is attached as Exhibit “B”. The Preliminary Statement, Findings of Fact, Conclusions of Law, and Recommendation contained in the Recommended Order are hereby adopted *in toto* and incorporated herein by reference.

Based upon the foregoing, and being otherwise fully advised in the premises, it is hereby ORDERED that:


4. Administrative Fine: Respondent shall pay an administrative fine totaling **\$3,000.00** to the Department of Business and Professional Regulation. This shall be paid in the manner described in the Method of Payment section below.

5. Investigative Cost: Respondent shall pay the investigative costs in the amount of **\$624.78** to the Department of Business and Professional Regulation. This shall be paid in the manner described in the Method of Payment section below.

6. Method of Payment: The administrative fine and investigative costs total **\$3,624.78**. This payment shall be made within **365 days** of the effective date of this Final Order. Payment shall be sent to the Department of Business and Professional Regulation, Revenue Unit, 2601 Blair Stone Road, Tallahassee, FL 32399-2202.

7. This Final Order shall become effective on the date of filing with the Agency Clerk of the Department of Business and Professional Regulation.

NOTICE OF RIGHT TO APPEAL
