

THIS CAUSE is before me for entry of a final order concerning the Department's Administrative Complaint signed December 4, 2017, imposing an administrative fine of \$100 for a Class I violation of Rule 65C-22.001(11), Florida Administrative Code. This was the first Class I violation within a two-year period. The Recommended Order, dated April 25, 2018, concluded that the Department did not satisfy its burden of proof and recommended that the administrative complaint be dismissed. Neither party filed exceptions to the Recommended Order.

Accordingly, the Recommended Order is approved and adopted and the Administrative Complaint signed December 4, 2017, is **DISMISSED**.

**NOTICE OF RIGHT TO APPEAL**


