FINAL ORDER

THIS CAUSE having come before the School Board of Seminole County, Florida, at its regular meeting held at 5:30 p.m. on March 12, 2019, after due notice as required by law; the Administrative Law Judge, J. Bruce Culpepper, having submitted his Recommended Order to the School Board pursuant to section 120.57(3)(e), Florida Statutes; the School Board having received the record in the case and being otherwise fully advised in the premises;

IT IS THEREUPON ORDERED by the School Board of Seminole County, Florida, that:

1. The Recommended Order dated January 23, 2019, is incorporated by reference and is fully adopted, with the sole exception being the striking of the following sentence in paragraph 38 of the Recommended Order: "When he discovered that Cady Studios was not included on the list, he concluded that Cady Studios would not be awarded the Photography Services contract."
2. Petitioner's Exceptions not reflected in paragraph 1 above are hereby rejected.
3. Pursuant to School Board Policy 6326¹, Bid Protests, the protest bond was conditioned upon the payment of hearing costs in the event the protest shall be denied. "Hearing cost shall exclude attorney's fees incurred by the Board, but shall include but not be limited to

court reporter fees and charges rendered by the Division of Administrative Hearings.” Because the School Board is issuing a final order denying the Petition, the School Board reserves the right to enter an order on costs. Within 15 days of the issuance of the final order, the School Board may file a motion, which should include its evidence of costs incurred in this proceeding. The School Board will address any such motion at the next available meeting after the filing of the motion. As such, the School Board reserves jurisdiction to determine an award of costs.

4. Cady Studios, LLC’s Formal Written Protest and Petition for Formal Administrative Hearing with regard to RFP #17180001P-LL for districtwide yearbook and photography services was untimely filed, and is hereby **DISMISSED** with prejudice.




