THIS CAUSE is before me for entry of a final order concerning the Department's Administrative Complaint signed February 12, 2018, revoking Respondent's Gold Seal Designation and imposing fines in the amount of \$525.00 for violations of: sections 402.305(2), Florida Statutes, Chapter 65C-22.003(2) Florida Administrative Code, section 4 of the Child Care Facility Handbook, incorporated by reference in Florida Administrative Code Rule 65C-22.001(6). The Recommended Order, dated August 23, 2018, concluded that the Department satisfied its burden of proving the violations by clear and convincing evidence and recommended that the administrative complaint be upheld. Neither party filed exceptions to the Recommended Order.

Accordingly, the Recommended Order is approved and adopted and the February 12, 2018 Administrative Complaint is **UPHELD**.

NOTICE OF RIGHT TO APPEAL


