FINAL ORDER

THIS CAUSE concerns three administrative complaints issued by the Petitioner, Agency for Health Care Administration (“the Agency”) and requests for hearing filed by the Respondent, Pinewood Estates Assisted Living Facility, LLC, referred to the Division of Administrative Hearings.

FINDINGS OF FACT

1. The Agency issued three Administrative Complaints to the Respondent. (Ex 1)
2. The Respondent requested a formal hearing for each agency action and they were referred to the Division of Administrative Hearings and assigned to an Administrative Law Judge.
3. On January 11, 2019, after issuance of an Order to Show Cause on the Respondent, the Administrative Law Judge dismissed the petitions for hearing, relinquished jurisdiction for entry of a final order and closed the files. (Ex. 2)

IT IS THEREFORE ORDERED THAT:

1. The Respondent shall pay the Agency \$4,500.00. If full payment has been made, the cancelled check acts as receipt of payment and no further payment is required. If full payment has not been made, payment is due within 30 days of the Final Order. Overdue amounts are subject to statutory interest and may be referred to collections. 

NOTICE OF RIGHT TO JUDICIAL REVIEW

A party who is adversely affected by this Final Order is entitled to judicial review, which shall be instituted by filing one copy of a notice of appeal with the Agency Clerk of AHCA, and a second copy, along with filing fee as prescribed by law, with the District Court of Appeal in the appellate district where the Agency maintains its headquarters or where a party resides. Review of proceedings shall be conducted in accordance with the Florida appellate rules. The Notice of Appeal must be filed within 30 days of rendition of the order to be reviewed.
