**FINAL ORDER**


This matter comes before the Department of Highway Safety and Motor Vehicles for entry of a final order upon submission of an Order Closing Files and Relinquishing Jurisdiction issued January 15, 2019, by the Honorable Robert J. Telfer III, Administrative Law Judge of the Division of Administrative Hearings, based on Respondent's Withdrawal of Notices of Intent to Establish and Motion to Dismiss as Moot, filed January 14, 2019, copies of which are attached and incorporated by reference in this order.

The original petitions in this matter protested the establishment of Summerfield Auto Acquisitions, Inc., as a new point dealership for the sale and service of Chrysler, Dodge, Jeep, and Ram motor vehicles. In its unopposed motion, the manufacturer, Respondent FCA US LLC, withdraws its notices of intent to establish the proposed new point location, which was the sole

issue at dispute in the petitions. There being no further issues before the Department, the cases are now moot.

Upon review of the record in the above-styled case and being fully advised in the premises, the Department hereby dismisses the petitions as moot. Accordingly, it is **ORDERED** that the cases are **CLOSED**.

#### **NOTICE OF APPEAL RIGHTS**

A party adversely affected by this final order may seek judicial review as provided in section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d) and must be filed (*i.e.*, received by the Agency Clerk) within thirty days of rendition of this final order.

Filing with the Department's Agency Clerk may be accomplished by U.S. mail, express overnight delivery, hand delivery, facsimile transmission, or electronic mail.
