FINAL ORDER

Moreover, the facts, if any, rejected in paragraph 14 are not based upon competent substantial evidence in the record and modified paragraph 14 is as or more reasonable that the conclusions of law, if any, rejected in paragraph 14.

- 2. Findings of Fact paragraph 16 is modified by rejecting the final sentence. The Department does not, in this Final Order, take a position on the merits of any opinions expressed in the rejected sentence, which are editorial and are not relevant to the determination of this matter. Moreover, the facts, if any, rejected in paragraph 16 are not based upon competent substantial evidence in the record and modified paragraph 16 is as or more reasonable that the conclusions of law, if any, rejected in paragraph 16.
- 3. Conclusions of Law paragraph 26 is modified by rejecting the final sentence. The Department does not, in this Final Order, take a position on the merits of any opinions expressed in the rejected sentence, which are editorial and are not relevant to the determination of this matter. Moreover, the facts, if any, rejected in paragraph 26 are not based upon competent substantial evidence in the record and modified paragraph 26 is as or more reasonable that the conclusions of law, if any, rejected in paragraph 26.

Accordingly, Digital Accessories Corporation's petition for a hearing is dismissed as untimely.
