FINAL ORDER

THIS MATTER comes before the Department of Health ("Department") for consideration of a Recommended Order issued March 7, 2019.

This proceeding was initiated by the Petitioner's request for an administrative hearing pursuant to sections 120.569 and 120.57(1), Florida Statutes.

On December 14, 2018, a formal administrative hearing was held in Palatka, Florida, before Administrative Law Judge ("ALJ") Yolanda Green, Division of Administrative Hearings. At issue was whether Respondent, Shanace Isaac, was overpaid in the amount of \$809.46; and, if so, whether she should be required to repay that amount to Respondent.

On March 7, 2018, ALJ Green entered a Recommended Order which recommended that the Department enter a final order requiring Petitioner, Shanace Isaac, to repay the Respondent \$809.46. A copy of the Recommended Order is attached and incorporated herein as Attachment A.


No exceptions were filed to the Recommended Order.


