FINAL ORDER


Having reviewed the Administrative Complaint, and all other matters of record, the Agency for Health Care Administration finds and concludes as follows:

1. The Agency issued the attached Administrative Complaint and Election of Rights form to the Respondent. (Ex. 1) The parties have since entered into the attached Settlement Agreement, which is adopted and incorporated by reference into this Final Order. (Ex. 2)

2. The Notice of Intent to Deny is withdrawn and a conditional license will be issued to the Petitioner for a three (3) month period from the date of this Final Order. Should the Petitioner fail to comply with the terms of the Settlement Agreement, the remedy set forth in the Settlement Agreement shall be enforced by the Agency. The CHOW applicant shall have its administrator pass the assisted living facility CORE licensure during the conditional licensure period.

3. An administrative fine of \$22,000.00 is imposed on the Petitioner, which shall be STAYED on the condition that the Petitioner and its controlling interest, Mileidy Hernandez, not seek or hold any type license regulated by the Agency.



NOTICE OF RIGHT TO JUDICIAL REVIEW

A party who is adversely affected by this Final Order is entitled to judicial review, which shall be instituted by filing one copy of a notice of appeal with the Agency Clerk of AHCA, and a second copy, along with filing fee as prescribed by law, with the District Court of Appeal in the appellate district where the Agency maintains its headquarters or where a party resides. Review of proceedings shall be conducted in accordance with the Florida appellate rules. The Notice of Appeal must be filed within 30 days of rendition of the order to be reviewed.
