## FINAL ORDER

THIS CAUSE is before me for entry of a final order concerning the Department's Administrative Complaints dated November 16, 2018, and January 11, 2019, imposing fines totaling \$3,260 and revocation of their probationary license for committing Class I, II, and III violations of child care facility licensing standards. The Recommended Order, dated June 5, 2019, concluded the Respondent committed the violations as alleged in the Administrative Complaints, upheld the fines totaling \$3,260, and further recommended revocation of the probationary license but only for the January 11, 2019, Administrative Complaint. The Recommended Order held that the revocation of the probationary license was not appropriate as to the November 16, 2018, Administrative Complaint. Neither party filed exceptions to the Recommended Order.

Accordingly, the Recommended Order is approved and adopted, and the Administrative Complaints dated November 16, 2018, and January 11, 2019, are **AFFIRMED** in part.
