THIS CAUSE is before me for entry of a final order concerning the Department's January 22, 2019, Administrative Complaint imposing a fine in the total amount of \$5,110.00 and revocation of Respondent's license for committing a total of ten Class I violations and three Class II violations. The Recommended Order concluded the Department established five of the Class I violations and two of the Class II violations by clear and convincing evidence. It further recommended a total fine of \$1,350.00 and revocation of Respondent's license to operate a child care facility. Neither party filed exceptions to the Recommended Order
