FINAL ORDER

THIS CAUSE is before the State of Florida, Agency for Health Care Administration ("the Agency") concerning the preliminary denial of Certificate of Need ("CON") application No. 10570 submitted by North Florida Regional Medical Center, Inc. in the first Hospital Beds and Facilities batching cycle of 2019 to establish a 24-bed CMR hospital in District 3, Subdistrict 3-2, Alachua County, Florida.

1. CON Application No. 10570 sought to establish a 24-bed comprehensive medical rehabilitation hospital in health planning District 3, Alachua County, Florida.

2. The Agency published a notice of its decision granting the preliminarily denial of CON application No. 10570 in the *Florida Administrative Register*, Volume 45, Number 112, on

June 10, 2019.

3. On July 1, 2019, North Florida Regional Medical Center timely filed a petition challenging the denial of its application. The Petition was referred to the Division of Administrative Hearings for a *de novo* review of the decision through a formal administrative hearing.

4. On August 1, 2019, Archer Rehabilitation, LLC d/b/a UF Health Rehab Hospital which operates a 50-bed rehabilitation hospital in District 3, Alachua County, Florida filed a Motion to Intervene supporting the Agency denial of CON application 10570. The ALJ entered an "Order Granting 'Motion to Intervene'" on August 6, 2019, subject to proof Archer Rehabilitation, LLC d/b/a UF Health Rehab Hospital is substantially affected and has standing to participate in the final hearing.

5. On August 16, 2019, North Florida Regional Medical Center voluntarily dismissed its petition.

6. On August 26, 2019, the Administrative Law Judge entered an Order Closing File and Relinquishing Jurisdiction to the Agency.

It is therefore, **ORDERED**

1. The petition for formal hearing is dismissed.

2. The denial of CON application No. 10570 is UPHELD and adopted as the final Agency decision.
