FINAL ORDER

THIS CAUSE came on for consideration before the Agency for Health Care Administration (“the Agency”), which finds and concludes as follows:


1. The Agency issued the Respondent, an Administrative Complaint [AHCA No.: 2018010618, AHCA No.: 2018005817 and AHCA No.: 2018006821] (Ex. 1), and an Administrative Complaint [AHCA No.: 2019004850] (Ex.2). The Agency was prepared to issue the Respondent an Administrative Complaint [AHCA No.: 2019016097, AHCA No.: 2019016380, AHCA No.: 2020003342 and AHCA No.: 2020001780]. The parties have since entered into the attached Settlement Agreement (Ex. 3), which is adopted and incorporated by reference.

Based upon the foregoing, it is **ORDERED:**

3. The Respondent shall pay the Agency administrative fines of \$7,000.00. If full payment has been made, the cancelled check acts as receipt of payment and no further payment is required. If full payment has not been made, payment is due within 120 days of the entry of the Final Order. Overdue amounts are subject to statutory interest and may be referred to collections. NOTICE OF RIGHT TO JUDICIAL REVIEW

A party that is adversely affected by this Final Order is entitled to seek judicial review which shall be instituted by filing one copy of a notice of appeal with the agency clerk of AHCA, and a second copy, along with filing fee as prescribed by law, with the District Court of Appeal in the appellate district where the agency maintains its headquarters or where a party resides. Review of proceedings shall be conducted in accordance with the Florida appellate rules. The notice of appeal must be filed within 30 days of rendition of the order to be reviewed.
