**SETTLEMENT AGREEMENT**

This settlement agreement is entered into by and between the Petitioner, **ST. PAUL'S CATHOLIC SCHOOL EARLY LEARNING CENTER** (herein after referred to as "St. Paul's") and Respondent, **DEPARTMENT OF CHILDREN AND FAMILIES** (herein after referred to as "DCF") in case number, 19-5098; and Petitioner, **PALMER CATHOLIC**

**ACADEMY PRESCHOOL** (herein after referred to as "Palmer") and Respondent, **DEPARTMENT OF CHILDREN AND FAMILIES** in case number, 19-5750, and Petitioner, **CHRIST THE KING CHILD CARE** (herein after referred to as "Christ the King"), and Respondent, **DEPARTMENT OF CHILDREN AND FAMILIES** in case number, 19-6638, for the purpose of settling, resolving, compromising and concluding the above styled administrative litigation, arising from the Denial of Religious Exemptions for each of the Petitioners in each of the above referenced cases and for the purpose of settling, resolving, compromising and concluding the above styled administrative litigation, arising from the currently pending requests for a Formal Hearing filed by each Petitioner as a result of DCF's denial of its application for religious exemption. The Petitioners and DCF hereby agree to the following:

1. Palmer is a daycare center under the domain of the Diocese of St. Augustine operating the Palmer Catholic Academy Preschool, located at 545 A1A North, Ponte Vedra Beach, Florida 32082.
2. Palmer operates under the license issued by DCF, number C07SJ00029, which was issued on March 31, 2019, and expires, March 30, 2020.
3. St. Paul's is a daycare center under the domain of the Diocese of St. Augustine operating the St. Paul's Catholic School Early Learning Center, located at 578 1<sup>st</sup> Avenue North, Jacksonville Beach, Florida 32250.
4. St. Paul's operates under the license issued by DCF, number C04DU0890, which was issued on August 3, 2019, and expires, August 2, 2020.
5. Christ the King is a daycare center under the domain of the Diocese of St. Augustine operating the Christ the King Child Care, located at 720 Arlington Road, Jacksonville, Florida 32211.
6. Christ the King operates under the license issued by DCF, number C04DU0780, which was issued on August 14, 2019 and expires, August 13, 2020.
7. On October 24, 2019, Petitioner, Palmer submitted to DCF its notification for religious exemption operation of a child care facility.
8. On October 25, 2019, DCF issued its Notice of Denial of that notification for religious exemption operation of a child care facility.



9. The denial was based on the fact that the child care facility is currently licensed by DCF, and on the basis of the language contained in Section 402.316(3), Florida Statutes, which states:

(3) Any child care facility covered by the exemption provisions of subsection (1), but desiring to be included in this act, is authorized to do so by submitting notification to the department. Once licensed, such facility cannot withdraw from the act and continue to operate.

10. On August 20, 2019, Petitioner, St. Paul's submitted to DCF its notification for operation of a child care facility under religious exemption.

11. On August 27, 2019, DCF issued its Notice of Denial of that notification for operation of a child care facility under religious exemption.

12. The denial was based on the fact that the child care facility is currently licensed by DCF, and on the basis of the language contained in Section 402.316(3), Florida Statutes which states:

(3) Any child care facility covered by the exemption provisions of subsection (1), but desiring to be included in this act, is authorized to do so by submitting notification to the department. Once licensed, such facility cannot withdraw from the act and continue to operate.

13. On October 28, 2019, Petitioner, Christ the King submitted to DCF its notification for operation of a child care facility under religious exemption.

14. On November 20, 2019, DCF issued its Notice of Denial of that notification for operation of a child care facility under religious exemption.

15. The denial was based on the fact that the child care facility is currently licensed by DCF, and on the basis of the language contained in Section 402.316(3), Florida Statutes which states:

(3) Any child care facility covered by the exemption provisions of subsection (1), but desiring to be included in this act, is authorized to do so by submitting notification to the department. Once licensed, such facility cannot withdraw from the act and continue to operate.

16. As a result of the denials, Palmer, St. Paul's, and Christ the King timely filed their Requests for Formal Hearing and referral of this matter to DOAH.
17. All three cases contain common, if not identical, issues of law and fact and in the interest of resolving those disputed issues, Palmer, St. Paul's, and Christ the King, and DCF choose to resolve and settle this case as set forth herein.
18. The parties agree that Palmer, St. Paul's, and Christ the King, at the expiration of their respective current DCF licenses, may apply for the religious exemption, pursuant to s. 402.316(3), Florida Statutes, and shall not be denied that exemption solely because the entity was previously licensed by DCF.
19. The Petitioners, Palmer, St. Paul's, and Christ the King, may submit their respective notification of religious exemption and all required supporting documents within the thirty (30) day period prior to the expiration date of their current licenses.
20. Petitioners do not intend to withdraw from licensure. The sole purpose of allowing the submission of the application for religious exemption during this period, is to ensure there is no interruption between the expiration of a license and the commencement of a religious exemption.
21. DCF reserves the right to deny the notification of religious exemption filed by licensed entities that fail to provide all supporting documentation to prove qualification for a religious exemption pursuant to s. 402.316(1), Fla. Stat.
22. Upon receipt of Petitioners' notification of religious exemption and all required supporting documents, DCF will immediately review the documentation. If any documents are missing, DCF will notify the Petitioners within one business day what documentation is missing.
23. So long as the Petitioners meet the qualifications pursuant to s. 402.316(1), Fla. Stat., the Department will approve the religious exemption effective the day after their current license expires so that there is no interruption between the expiration of the current license and the commencement of a religious exemption.
24. The parties agree that it is their intention that the exemption notification process set forth above shall also apply to other faith based qualified entities that are an

integral part of the Diocese of St. Augustine, assuming they are in compliance with all other DCF requirements.

25. DCF reserves the right to not recognize the operation of a child care facility under religious exemption filed by licensed entities that have a history of disciplinary action and/or are pending disciplinary action. This includes Petitioners should they commit a violation or violations before the end of their current licensing period that require disciplinary action be taken by DCF.
26. In consideration of the foregoing agreement and undertakings by the Petitioners, Palmer, St. Paul's, and Christ the King, and the Respondent, DCF, and upon receipt of the executed copy of this settlement agreement, the Petitioners agree to issue a voluntary dismissal and/or request the Administrative Law Judge to enter the appropriate Order of Dismissal of this matter.
27. This agreement encompasses the entire understanding between the parties to this matter, and there are no undertakings of the parties to each other relative to this matter that are not set forth herein.
28. Each party shall bear its own attorney's fees and costs.
29. This agreement shall become effective immediately upon the execution of the last signature.
30. The parties represent, each to the other, that the individuals executing this settlement agreement have the requisite authority to enter this agreement and bind their respective principals to its terms and conditions.


