## FINAL ORDER APPROVING SETTLEMENT AGREEMENT

This cause is before the Agency for Persons with Disabilities ("Agency") for entry of a Final Order Approving Settlement Agreement entered into between the Agency and Tampa Bay Group Homes, Inc. ("Respondent"), which is attached as Exhibit A.

On December 13, 2019, the Agency filed an Administrative Complaint against three of Respondent's facilities: Harbor Woods Group Home (license number 5419-6-GA), Old Oak Group Home (license number 5458-6-GA), and Princeton Group Home (license number 5343-6-GA). On January 13, 2020, the Respondent timely filed a Request for Administrative Hearing and the hearing was referred to the Division of Administrative Hearings ("DOAH"). On May 7, 2020,

- 4. Any violation of this Settlement Agreement is considered a violation of the Final Order.

## **NOTICE OF RIGHT TO APPEAL**

The Notices must be filed within thirty (30) days of the rendition of this final order.<sup>1</sup>
