FINAL ORDER

THIS CAUSE came before me for final action on Florida's Best Roofing and Gutters, LLC's ("Employer") request for administrative review ("petition") challenging a Stop-Work Order and Order of Penalty Assessment ("Stop-Work Order), and an Amended Order of Penalty Assessment.

FINDINGS OF FACT

1. On June 6, 2019, the Department of Financial Services, Division of Workers' Compensation ("Department"), served Employer the Stop-Work Order.
2. On June 17, 2019, the Department and Employer executed an Agreed Order of Conditional Release from Stop-Work Order ("Conditional Release"), wherein Employer agreed to pay the Department the penalty assessed against Employer.
3. On July 1, 2019, the Department received Employer's petition.

4. On November 22, 2019, the Department served Employer an Amended Order of Penalty Assessment. The Amended Order of Penalty Assessment assessed a total penalty of \$1,000.00, which Employer has paid in full.

5. On February 5, 2020, Employer withdrew its Petition.

6. The factual allegations contained in the Stop-Work Order and the Amended Order of Penalty Assessment are hereby adopted as the Department's findings of fact in this case.

CONCLUSIONS OF LAW

7. Based upon the findings of fact adopted herein, the Department concludes Employer violated the specific statutes and rules as alleged in the Stop-Work Order and the Amended Order of Penalty Assessment.

8. The Stop-Work Order issued to Employer in this matter is released.

NOTICE OF RIGHT TO APPEAL

A party adversely affected by this final order may seek judicial review as provided in section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d), and must be filed (i.e., received by the Agency Clerk) within thirty days of rendition of this final order.
