**FINAL ORDER**

This matter comes before the Department of Highway Safety and Motor Vehicles for entry of a final order upon submission of the Order Closing File and Relinquishing Jurisdiction issued September 18, 2020, by the Honorable Linzie F. Bogan, Administrative Law Judge of the Division of Administrative Hearings, based on Respondent's September 10, 2020, withdrawal of its notice of intention to establish Next Ride, LLC d/b/a Next Ride as a dealership for the sale of motorcycles manufactured by Piaggio Group Americas, Inc. (line-make PIAG) and Petitioner's Motion to Dismiss as Moot, filed September 17, 2020.

Respondents' application for the proposed new point franchise location having been withdrawn, the petition is moot. Accordingly, the petition is **DISMISSED**, and the case is **CLOSED**. If Respondents subsequently reapply for this franchise location, notice of a new application must be published in the Florida Administrative Register pursuant to § 320.642(1), Fla. Stat.

### **NOTICE OF APPEAL RIGHTS**

A party adversely affected by this final order may seek judicial review as provided in § 120.68, Fla. Stat., and Fla. R. App. P. 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Fla. R. App. P. 9.110(d) and must be filed (*i.e.*, received by the Agency Clerk) within thirty days of rendition of this final order.
