## FINAL ORDER OF DISMISSAL

THIS CAUSE is before me for issuance of a Final Order of Dismissal. The case was based on an Agency Action Letter, dated December 26, 2019, that notified the provider of adjustments made to their facility's Medicaid reimbursement rates (Agency Action Letter attached as Exhibit "1"). On January 17, 2020, Petitioner filed a timely Petition for a Formal Administrative Hearing.

On February 6, 2020, the Petitioner requested that the Agency hold the petition in abeyance in order to afford the parties an opportunity to resolve the disputed balance. The case was kept in abeyance for 90 days while the parties attempted to resolve all outstanding issues. On June 23, 2020, the Agency filed the Petitioner's request for a formal administrative hearing with the Division of Administrative Hearings (attached as Exhibit "2").

On August 13, 2020, the Petitioner filed a Motion to Relinquish Jurisdiction and is no longer disputing the fine (attached as Exhibit "3"). On August 14, 2020 the Administrative Law Judge issued an Order relinquishing jurisdiction to the Agency and closing the file. (attached as Exhibit "4").

Based on the foregoing request from the Petitioner, the case is hereby DISMISSED.
