ORDER CLOSING FILE AND RELINQUISHING JURISDICTION

This cause comes before the undersigned on Petitioner's Motion to Relinquish Jurisdiction. An email to Petitioner's counsel from Respondent's owner, who proceeds without counsel in this matter, expressing despair about the sanction process, was attached to the motion. Respondent, however, did not file a pleading stating that it desired to withdraw the hearing request. The email also did not state that Respondent authorized counsel for Petitioner to represent that Respondent wished to withdraw its request for hearing. The email stated, "If you could just send me what I need to end this process."

On October 21, 2020, the undersigned issued an Order to Respond to Motion to Relinquish. The Order required Respondent to file a response, no later than October 28, 2020, stating whether it wishes to withdraw the request for hearing. The Order stated: "If Leapin Lizards Academy, LLC, does not file a response, that will be taken as a statement that Leapin Lizards wishes to withdraw its request for a hearing, and jurisdiction of the case will be relinquished to the Department of Children and Families."

Respondent has not filed a response as ordered. Consequently the Formal Administrative Hearing Request is deemed withdrawn. It is ordered that:

- 1. The hearing scheduled for October 30, 2020, is canceled.
- 2. The file of the Division of Administrative Hearings for this matter is closed.
- 3. Jurisdiction of this matter is relinquished to the Department of Children and Families.
