FINAL ORDER

This matter came before the Department of Economic Opportunity (DEO) for entry of a final order upon the issuance of a Recommended Order by an Administrative Law Judge (ALJ) assigned by the Division of Administrative Hearings (DOAH).

BACKGROUND

On September 3, 2020, Petitioner, Suzanne L. Jacobs, filed a Petition for Relief (Petition) in which she contested a determination by DEO that her application for assistance from the Rebuild Florida Hurricane Irma Single-Family Repair and Replacement Program (HRRP) did not meet the eligibility requirements to receive funding. Specifically, DEO determined "there are no remaining unrepaired damages that are attributable to Hurricane Irma." DEO referred the Petition to DOAH, requesting an administrative hearing be held. Prior to the scheduled April 15, 2021, hearing, DEO filed a Motion to Dismiss in which it stipulated that there are remaining damages to Petitioner's house attributable to Hurricane Irma and Petitioner is entitled to proceed to the next step in the HRRP application review process.

On April 20, 2021, the ALJ issued a Recommended Order of Dismissal in this matter granting DEO's Motion to Dismiss and recommending that, based on DEO's stipulation of remaining damages attributable to Hurricane Irma, there no longer exists any disputed issues of material fact to be considered. The ALJ relinquished jurisdiction to DEO and recommended that DEO issue a final order dismissing the Petition.

No exceptions were filed to the ALJ's Recommended Order of Dismissal.

ORDER

IT IS THEREFORE ORDERED as follows:

- 1. The Recommended Order of Dismissal is adopted and incorporated by reference.
- 2. DEO's determination denying Petitioner's application for assistance under HRRM is reversed.
- 3. Petitioner shall be allowed to proceed to the next step of the application review process.

A COPY OF THE NOTICE OF APPEAL MUST ALSO BE FILED WITH THE APPROPRIATE DISTRICT COURT OF APPEAL AND MUST BE ACCOMPANIED BY THE FILING FEE SPECIFICED IN SECTION 35.22, FLORIDA STATUTES.
