FINAL ORDER OF DISMISSAL AS MOOT

This cause is before the Agency for Persons with Disabilities ("Agency" or "APD") for entry of a Final Order dismissing 2 Heart to Heart Group Home, Inc.'s ("Respondent"), request for an administrative hearing as the issue is moot.

On or about August 10, 2020, Respondent submitted an application for the licensure of 2 Heart to Heart #3 Group Home as an APD group home facility. On October 27, 2020, the Agency issued a Notice of License Application Denial to Respondent. On November 17, 2020, Respondent's counsel filed a Petition for Administrative Hearing on Denial of Group Home Facility License Application with the Agency Clerk. On November 19, 2020, the Agency referred the case to the

Division of Administrative Hearings ("DOAH"), who assigned case number 20-5109FL.

While 20-5109FL was ongoing, the Agency received additional information regarding the application and decided to approve Respondent's application for 2 Heart to Heart #3 Group Home to be licensed as an APD group home facility pursuant to sections 393.0673 and 120.60, Florida Statutes.

On December 1, 2020, the Agency filed an Unopposed Motion to Relinquish Jurisdiction with the Division of Administrative Hearings. In it, the Agency stated that the parties had resolved the case without a need for a hearing. On December 1, 2020, the Administrative Law Judge issued an Order Closing File and Relinquishing Jurisdiction.

Pursuant to sections 120.52(7) and 120.569(1), Florida Statutes, given that all issues have been resolved, this matter is DISMISSED as MOOT. This Final Order shall take effect upon filing with the Clerk of the Agency for Persons with Disabilities.
