FINAL ORDER

THIS CAUSE came before me for final action on Blue Water Signature Homes, Inc.'s ("Employer") request for administrative review ("petition") challenging a Stop-Work Order for Specific Worksite Only and Order of Penalty Assessment ("Stop-Work Order), and a 2nd Amended Order of Penalty Assessment.

FINDINGS OF FACT

- 1. On March 21, 2018, the Department of Financial Services, Division of Workers' Compensation ("Department"), served Employer the Stop-Work Order.
- 2. On March 21, 2018, the Department and Employer executed an Agreed Order of Conditional Release from Stop-Work Order ("Conditional Release"), wherein Employer agreed to pay the Department the penalty assessed against Employer.
- 3. On June 15, 2018, the Department served Employer an Amended Order of Penalty Assessment. The Amended Order of Penalty Assessment assessed a total penalty of \$54,263.84.

- 4. On August 1, 2018, the Department served Employer a 2nd Amended Order of Penalty Assessment. The 2nd Amended Order of Penalty Assessment assessed a total penalty of \$54,263.84.
 - 5. On August 17, 2018, the Department received Employer's petition.
- 6. On September 14, 2021, Employer withdrew its Petition by oral motion in Division of Administrative Hearings Case Number 21-0345.
- 7. The factual allegations contained in the Stop-Work Order and the 2nd Amended Order of Penalty Assessment are hereby adopted as the Department's findings of fact in this case.

CONCLUSIONS OF LAW

- 8. Based upon the findings of fact adopted herein, the Department concludes
 Employer violated the specific statutes and rules as alleged in the Stop-Work Order and the 2nd
 Amended Order of Penalty Assessment.
- 9. Employer remains subject to the conditional release until the total penalty of \$54,263.84 is paid in full.
