
**FINAL ORDER**

THIS CAUSE is before the Department of Children and Families ("Petitioner") for entry of a Final Order concerning Petitioner's Administrative Complaint dated February 1, 2021. The Administrative Complaint sought a civil penalty in the amount of \$50 against It's a Small World Academy, Inc. ("Respondent") for failing to timely file its child care license renewal application, as required by Rule 65C-22.010(2)(c), *Florida Administrative Code*.

The Recommended Order dated August 17, 2021 concluded that the equities in this case lean in favor of Respondent and, therefore, the Administrative Complaint should be dismissed. Neither party filed exceptions.

Accordingly, the Recommended Order is adopted *in toto* and the Administrative Complaint is DISMISSED.
