## FINAL ORDER

THIS CAUSE is before the State of Florida, Agency for Health Care Administration ("the Agency") concerning the preliminary denial of Certificate of Need ("CON") Application No. 10648 filed by Cornerstone Hospice & Palliative Care, Inc. ("Cornerstone"), and the preliminary approval of CON Application No. 10649 filed by Hernando-Pasco Hospice, Inc. ("HPH"), to establish a new hospice program in hospice service area 5B, Pinellas County, Florida.

- 1. On June 21, 2021, the Agency published a notice in Vol. 47, No. 119 of the Florida Administrative Register setting out its decisions preliminarily denying CON Application No. 10648 filed by Cornerstone and preliminarily approving CON Application No. 10649 filed by HPH.
- 2. Cornerstone filed a Petition for Formal Administrative Hearing challenging the preliminary denial of its application and the preliminary approval of the HPH's application. The Petition was subsequently forwarded to the Division of Administrative Hearings for hearing.
- 3. On August 6, 2021, Cornerstone filed a Notice of Voluntary Dismissal withdrawing and dismissing its Petition for Formal Administrative Hearing.

It is therefore, ORDERED

- 1. The denial of CON Application No. 10648 is UPHELD.
- 2. The petitions concerning the denials of the other applications and approval of CON

Application No. 10649 remain pending at the Division of Administrative Hearings.
