FINAL ORDER

THIS CAUSE came before the Florida Fish and Wildlife Conservation Commission (Commission) on a Petition for a formal administrative hearing (Petition) filed by Jeffery David Wilenski (Petitioner or Wilenski). The Petition challenged the Commission's determination that Petitioner was responsible for a vessel deemed derelict and abandoned.

STATEMENT OF THE ISSUE

WHEREAS Wilenski received notification from the Commission on July 17, 2021, that that he was responsible for a vessel deemed derelict and abandoned on the waters of the State of Florida. Petitioner disputed the agency action. The letter further stated that law enforcement officers employed by Respondent had determined that Petitioner's vessel was derelict, as defined in section 823.11, and would be removed and disposed of, pursuant to Chapter 705, Florida Statutes, if the vessel was not removed within five days. Petitioner filed a timely petition challenging the action.

The matter was referred to the Division of Administrative Hearings (DOAH). The final hearing initially was set for September 9, 2021. On September 2, 2021, the parties filed an Agreed/Joint Motion for Continuance, requesting that the hearing be continued due to Petitioner

having contracted COVID-19. The hearing was continued and rescheduled for November 9, 2021. The hearing was held on as scheduled. After the hearing the parties filed proposed recommended orders, and both were considered in preparing the Recommended Order. On December 7, 2021, the hearing officer issued the Recommended Order finding for the Petitioner. The administrative law judge concluded that the vessel was not derelict and recommended that the agency enter a final order in favor of the Petitioner holding that is not derelict.

CONCLUSIONS OF LAW

Upon review of the record, the Commission makes the following legal conclusion:

As Executive Director of the Commission or his designee, the undersigned has jurisdiction over this subject matter and authority to enter a final order pursuant to Rule 68-1.009, Florida Administrative Code, and the Commission's Delegation of Authority, dated October 2020, and in accordance with Section 120.57(2), Florida Statutes.

<u>ORDER</u>

WHEREFORE, the Administrative Law Judge's Recommended Order is adopted, finding that the vessel at issue in this proceeding is not a derelict vessel under section 823.11 and that, as such, Respondent is not authorized to relocate, remove, store, or dispose of the vessel, as provided in sections 823.11 and 376.15 and this matter is closed.
