**FINAL ORDER**


Having reviewed the Notice of Intent to Deny, and all other matters of record, the Agency for Health Care Administration finds and concludes as follows:

1. The Agency issued the attached Notice of Intent to Deny Change of Ownership Application (“NOI”) to the Petitioner. (Ex. 1). The Petitioner filed a petition for a formal hearing pursuant to Section 201.57(1), Florida Statutes, and the case was forwarded to the Division of Administrative Hearings. Subsequently, the Petitioner filed a Motion to Relinquish Jurisdiction with the Division withdrawing the request for a formal hearing after withdrawing the license application. The Division closed its file and relinquished jurisdiction to the Agency. (Ex. 2).

Based upon the foregoing, it is **ORDERED**:

2. The Petitioner’s application for a change of ownership license is withdrawn.



**NOTICE OF RIGHT TO JUDICIAL REVIEW**

A party who is adversely affected by this Final Order is entitled to judicial review, which shall be instituted by filing one copy of a notice of appeal with the Agency Clerk of AHCA, and a second copy, along with filing fee as prescribed by law, with the District Court of Appeal in the appellate district where the Agency maintains its headquarters or where a party resides. Review of proceedings shall be conducted in accordance with the Florida appellate rules. The Notice of Appeal must be filed within 30 days of rendition of the order to be reviewed.
